AIPS Fellowships and Other News

NEW AIPS Short-Term Lecture and Research Fellowships in Pakistan 2010-11 Award Submission Deadlines: June 15 and September 1, 2010, and Jan 1, 2011 Applications are invited for short-term lecture and research fellowships for senior scholars at the post-doctoral level and for advanced graduate students at the pre-doctoral level. Duration of fellowships will be from one to five months. Fellows will be required to present a minimum of two lectures per month at approved host institutions (see Fellowship FAQ's) or the AIPS centers in Islamabad or Lahore. Each participant will be required to sign a release that stipulates the relevant security issues that need to be adopted.

Awards will include international travel expenses and stipends (subject to availability of funds). The amount of the stipends will be comparable to Fulbright Awards and will be determined by the Fellowships Committee based on availability of funds and current rates as defined by the U S State Department. (Total fellowship support can range from \$3,000 to \$25,000). Funds may be used for research on materials relating to the history and culture of Pakistan and must take place in Pakistan at approved locations (see Fellowship FAQ's on the AIPS website) Applicants must be U.S. citizens and enrolled/employed full-time in an institution of higher education in the USA.

CAORC Administrative Workshop Istanbul (August 2010)

The Council of American Overseas Research Center organized an administrative workshop for the ORCs at Armda Hotel, Istanbul, Turkey from August 7-11, 2010. The workshop was attended

by several US and Overseas directors as well as staff members of the CAORC member institutions. The Islamabad Director briefed the CAORC group on AIPS history and its programs in Pakistan. He highlighted some of the institute's strengths as well as challenges being faced by AIPS in pursuance of its scholarly mission in Pakistan. The workshop provided a great opportunity for all ORCs representatives to share ideas to learn from each others' experiences on different administrative and financial matters.

AIPS—Collaboration with Library of Congress in Lahore

Dr Mark Kenoyer (President, AIPS) in a meeting with the Dr Carol Mitchell (Field Director, Library of Congress, Islamabad) agreed to collaborate with LoC in Lahore for books acquisitions in Lahore through the AIPS-Lahore center. The LoC will use AIPS-center in Lahore and staff for part time work on this project. The LoC will provide some in-kind support to the Lahore center and will also compensate for staff time for the acquisition works in Lahore. In addition the LoC will also provide professional training to our Lahore center staff member "Mohammad Razaq" in books acquisitions works. A team from LoC, Islamabad office has already visited the AIPS-Lahore center in this respect and plans are underway to begin with training of AIPS staff member for this once a week assigned-work for LoC in Lahore.

Other Fellowships

There are many other granting agencies that provide fellowships in order to conduct work in Pakistan. The following information represents some additional options for funding for predoctoral candidates, post-doctoral candidates and scholars interested in working on material related to Pakistan.

The South Asia Council of the Association for Asian Studies announces the 2010 competition for the best paper presented by a graduate student at the annual conference of the AAS. The prize will recognize emerging scholarship in the field, and foster intellectual exchange among junior and senior scholars. The award of \$100.00 and a certificate will be presented at the 2011 Annual Conference of the AAS in Hawaii. The South Asia Council of the AAS will also provide a sum of \$300.00 to the winner of the prize, to partially cover the cost of his or her travel to the Hawaii Conference, where the winner will be recognized at the AAS Graduate Student reception.

The Council encourages graduate students who presented papers at the March 2010 conference in Philadelphia to submit their papers for consideration. Papers on any aspect and region of South Asia will be considered. Students must be registered in a doctoral program in order to be considered for the Prize.

Please email your paper as an attachment to Matt Nelson and Vinayak Chaturvedi by May 31, 2010. Papers submitted to the Council after this deadline will not be considered.

CAORC: The Council of American Overseas Research Centers develops and administers programs in collaboration with our member Centers and affiliated partners.

The Council of American Overseas Research Centers (CAORC) Multi-Country Fellowship Program supports advanced regional or trans-regional research in the humanities, social sciences, or allied natural sciences for U.S. master's students, doctoral candidates, and scholars who have already earned their Ph.D. Preference will be given to candidates examining comparative and/or cross-regional research. Applicants are eligible to apply as individuals or in teams.

Scholars must carry out research in two or more countries outside the United States, at least one of which hosts a participating American overseas research center. Approximately ten awards of up to \$12,000 each will be given in the doctoral candidate/post-doctoral scholar competition. Approximately four awards of up to \$8,000 each will be given in the master's student competition. Given changing travel restrictions and/or security warnings to many countries, applicants should contact CAORC before preparing a proposal.



The Most Dangerous Place: Pakistan's Lawless Frontier


Explaining Pakistan's Foreign Policy: Escaping India By Aparna Pande. Forthcoming: March 2011 Routledge Contemporary South Asia Series

Temples of the Indus: Studies in the Hindu Architecture of Ancient Pakistan


In Pakistan's northwest, a sequence of temples built between the sixth and the tenth centuries provides a missing chapter in the evolution of the Hindu temple in South Asia. Combining some elements from Buddhist architecture in Gandharā with the symbolically powerful curvilinear Nāgara tower formulated in the early post-Gupta period, this group stands as an independent school of that pan-Indic form, offering new evidence for its creation and original variations in the four centuries of its existence. Drawing on recent archaeology undertaken by the Pakistan Heritage Society as well as scholarship from the Encyclopaedia of Indian Temple Architecture project, this volume finally allows the Salt Range and Indus

temples to be integrated with the greater South Asian tradition.

S Akbar Zaidi, is a Karachi-based social scientist who specializes in the field of political economy. He taught at Karachi University for nearly fifteen years and continues to lecture at universities in Pakistan and abroad. Most recently (2004-05) he was a Visiting Professor at the School of Advanced International Studies at Johns Hopkins University. He conducts research and has published twelve books, two of which, Issues in Pakistan's Economy (OUP, 1999) and The New Development Paradigm: Papers on Institutions, NGOs, Gender and Local Government (OUP, 1999), have become standard textbooks for graduate and postgraduate courses on Pakistan's economy and Development Economics, both in Pakistan and abroad. He has published in numerous international professional journals on themes as diverse as devolution, health sociology, local government, fiscal policy, and international financial institutions. He is currently a visiting faculty at Columbia University.

Editorials of Note

AIPS, its office bearers or the editors of this Newsletter do not in any form endorse the views expressed in the following three articles. They are presented here as a service to our members in order to share opinions expressed on important current issues in Pakistan.

The devastating floods in Pakistan have been extensively covered in the international media. The first two articles chosen here by Humeira Iqtidar (South Asia Center, Cambridge University) and by Mushtaq Gadi (Quaid e Azam University, Islamabad) provide an alternative analysis to what is normally reported. There is some overlap in the argument as both pieces discuss the infra-structural issues (dams, barrages) that may have increased the intensity of this "natural disaster". Both articles hence take us away from the "naturalness" of the disaster and help us focus on issues of deforestation, ill designed infra-structural projects, the lack of water drainage systems and the neglect and callousness of the political elite. Iqtidar's article builds on this theme to also give ethnographic evidence from the affected communities and shows the forms in which aid has been organized by locals themselves. The third article by Pervez Hoodbhoy (Quaid e Azam University, Islamabad) takes up the issue of higher education in Pakistan. Irrespective of whether we agree with his assessment or with the conclusions that the author draws from his analysis, the opinion piece raises pertinent and provocative questions for those who remain interested in the state of higher education in Pakistan.
